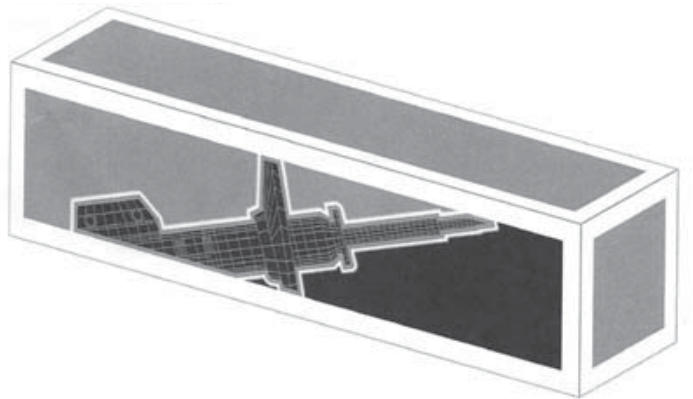

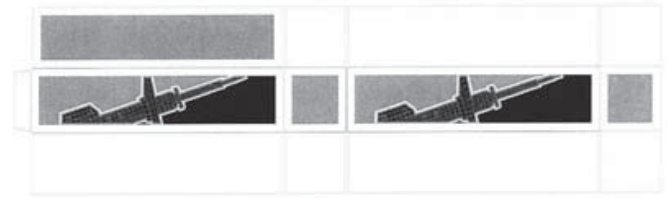
[A-A Cross sectional view]
